AFTER PASSING THE QUALIFYING EXAMINATION THE STUDENT SHOULD ALSO UNDERGO A JOB TRAINING IN SUMMER AS PART OF THE REQUIREMENT OF SYNTHESIS. ( 1 UNIT TO BE CREDITED IN THE FIRST SEMESTER OF THE FIFTH YEAR.
